Held July15th, 2015

## Hortt Park Community Center

The Shady Bank's Civic Association Board Meeting was called to order at 7:02 pm by President Barbara Haggerty.

The official police updates were presented by NAT officer Mr. L. Fernandez. There were quite a few automobile burglaries in the past month. 10 out of 12 of these were due to unlocked car doors. Please make sure to lock any unlocked doors. More details about crimes reported by neighbors can be found in real time on NextDoor.com viewing Shady Banks. The official neighborhood statistics can be found at FLPD.org.

The Treasury Report was presented by Treasurer Don Haggerty with \$13,389.45 residing in the account-the same amount as last month, since there were no transactions. The Board approved the report.

Minutes from the SBCA meeting of June 17<sup>th</sup>, 2015 were reviewed and approved by the Board.

Committees gave updates on their progress. A lengthy vote was made on the trees surrounding the tennis courts with the following 4 options voted upon.

- 1) Keep tennis courts in the original location with 5 trees being removed
- 2) Relocate tennis court layout 10 feet east to avoiding removing all 7 trees
- 3) Relocate tennis court at an angle at the back side of the community center (not a favorable view)
- 4) Shut down the entire project

Voting Results:

- 1) Original location: 6 for, 4 against
- 2) Relocate 10 feet: 0 for, 10 against
- 3) Relocate at angle: 2 for, 8 against
- 4) No tennis courts: 2 for, 8 against

Speaking on behalf of the Safety Committee, Shelby Smith provided updates on the progress of the speed study for the neighborhood on 12<sup>th</sup> court. The speed study will be given to the entire neighborhood, not just one street. Everything will be taken into account, even the affect the raised bridge has on the neighborhood. Shady Banks is on a waiting list for the speed study with an expected start date of October 2015.

Movies In the Park will be postponed for the month of August because of the heat.

## SBCA Meeting, July 15<sup>th</sup>, 2015

New crime watch signs are not available with the City or Police Department. Gene Groves volunteered to research alternative methods of crime watch signs.

Club 55 is holding meetings in Hortt Community center every morning throughout the summer and on Tuesdays and Thursdays on a permanent basis.

There was more discussion on the possibility of a neighborhood survey to research and encourage resident participation. Actual wording of the survey question to be approved via email.

The next Board Meeting will be September 16<sup>th</sup> at 7pm.
