What is a "Community Residence" and why do we need to locate all of them? They are also called "Sober Homes" or "Transitional Residences" and the City is beginning to regulate their location and require that they be Certified.

We need an accurate survey of existing facilities in order to administer these new regulations. This is a process similar to asking for neighborhood help in locating "Vacation Rentals".
